Gaia Rating, agence de notation ESG d'EthiFinance, mène une campagne annuelle de collecte de données couvrant l'essentiel des PME-ETI cotées en France. Sur la base de ces informations, les sociétés sont notées sur leur niveau de transparence et de performance. Des classements ont été établis par catégorie de chiffre d'affaires afin de récompenser les meilleurs acteurs à partir d'un panel restreint de 230 PME-ETI cotées à la bourse de Paris respectant 3 critères de taille et un critère de liquidité. Les notations sont utilisées par des sociétés de gestion de premier plan dans leur processus de gestion et décisions d'investissement.

Voltalia joins the Gaïa-Index, French reference SRI index

Voltalia (Euronext Paris, ISIN code: FR0011995588), an international player in renewable energies, was selected for inclusion in the 2018 Gaïa Index, a recognized benchmark in the field of Socially Responsible Investment (SRI) for French midcap companies, which distinguishes best performers in terms of Corporate Social Responsibility (CSR).

By appearing in the Gaïa-Index, Voltalia is joining the 70 best performers out of 230 French listed companies assessed in the rating campaign, hence gaining visibility with SRI investors.

The rating is based on a set of more than 130 non-financial criteria (societal, social, environmental, and governance-related) which enable to appraise the level of transparency and maturity of companies with regard to their CSR policies, practices and performances.

“Assessed for the first time this year, we are very proud to be selected for inclusion in the Gaïa Index. This comes as a recognition of the commitment of Voltalia and its 490 employees to Corporate Social Responsibility. In fact, CSR is at the very core of our mission, as we strive to “improve global environment while fostering local development”. Joining the index is a sign of our willingness to bring forward an overall performance which goes well beyond our financial performance”, says Marie de Lauzon, Chief Administrative Officer of Voltalia.

The Gaïa-Index is a recognized benchmark for medium-size listed companies in France regarding Sustainable Development. It was created by Ethifinance with the purpose to assess midcaps based on their extra-financial performance, notably in terms of transparency and maturity regarding their CSR policies, practices and performance. Every year since its creation in 2009, the Gaïa Index has outperformed the CAC40 and the CAC Mid & Small indices.
